### . Definitions

In these conditions:

"ACL" means the Australian Consumer Law Schedule to the Competition and Consumer Act;

"Agreement" means any agreement for the provision of goods or services by FlexCAM to the Customer;

"Consumer" is as defined under the ACL and in determining if the Customer is a consumer, the determination is made if the Customer is a consumer under the Agreement;

"Customer" means a person, jointly and severally if more than one, acquiring goods or services from FlexCAM;

"FlexCAM" means, FlexCAM Pty Ltd of 2A Evolution Dr, Dandenong South, Victoria 3175;

"Goods" means all goods supplied by FlexCAM to the Customer including those goods subject to a Project as well as other spare parts, components and equipment.

"GST" means the Goods and Services tax as defined in A New Tax System (Goods and Services Tax) Act 1999 as amended:

"Intellectual Property" means all copyright, patents, trademarks, designs, specifications, confidential information, manufacturing processes and all modifications, improvements and derivations (whether registrable or not) owned or licensed by FlexCAM in respect of the goods and services:

"PPSA" means the Personal Property Securities Act 2009 as amended;

"Price List" means the price list issued by FlexCAM from time to time;

"Project" means the installation of goods where FlexCAM personnel are engaged in the installation and commissioning;

"Services" means services supplied by FlexCAM to the Customer;

"Terms" means these Terms and Conditions of Sale; and

**"Testing"** means the running of any goods for the purposes of adjustment, set up, alignment or commissioning of the goods supplied.

### 2. Basis of Agreement

- 2.1 Unless otherwise agreed by FlexCAM in writing, the Terms apply exclusively to every Agreement and cannot be varied or replaced by any other conditions, including the Customer's terms and conditions of purchase (if any).
- 2.2 Any quotation provided by FlexCAM to the Customer for the proposed supply of goods or services is:
- (a) valid for 30 days;
- (b) an invitation to treat only;
- (c) only valid if in writing.
- 2.3 In case of inconsistencies between these Terms and an order specific term or condition set forth in the Agreement (including but not limited to FlexCAM quotation when part of the Agreement), the Agreement shall prevail.
- 2.4 An Agreement is accepted by FlexCAM when FlexCAM accepts, in writing or electronic means, an offer from the Customer or provides the Customer with the goods or services.
- 2.5 FlexCAM has absolute discretion to refuse to accept any offer.
- 2.6 The Customer must provide FlexCAM with its specific requirements, if any, in writing in relation to the goods and services.
- 2.7 FlexCAM may vary or amend these Terms by written notice to the Customer at any time. Any variations or amendments will apply to orders placed after the notice date.

# 3. Pricing

- 3.1 Prices quoted, whether in the Price List, by written quotation or verbally, for the supply of goods and services, exclude GST and any other taxes or duties imposed on or in relation to the goods and services. In addition to payment of the price of goods and services, the Customer must pay any GST and any other taxes or duties imposed on the goods and services.
- 3.2 Prices are quoted DDP INCOTERMS 2010 unless otherwise stated in writing.
- 3.3 If the Customer requests any variation to the Agreement, FlexCAM may increase the price and adjust other terms such as the time of delivery to account for the variation.
- 3.4 Where there is any change in the costs incurred by FlexCAM in relation to the goods or services, FlexCAM may vary its price for the goods or services in order to take account of any such change, by notifying the Customer.

## 4. Paymen

- 4.1 Subject to clause 4.2 and unless otherwise agreed in writing:
- (a) Where the Agreement is for services only, full payment must be made within 7 days of the date FlexCAM invoice is raised:
- (b) Agreements for goods only will, at FlexCAM sole discretion, be invoiced in instalments being:
- 30% of the value on acceptance of the order by FlexCAM payable within 7 days of the date of the invoice or prior to delivery, whichever is the sooner; and
- (ii) 70% at ready for delivery to the Customer and payable within 30 days of the date of invoice;
- (c) Agreements for goods and services that are valued at less than \$10,000 will be invoiced in full on acceptance of the order by FlexCAM, the payment for which must be made within 30 days of the date FlexCAM's invoice is raised or prior to despatch, whichever is the sooner;
- (d) Agreements for goods and services that are valued equal to or greater than \$10,000 will, at FlexCAM's sole discretion, be invoiced in instalments being :
- (i) 30% of the value on acceptance of the order by FlexCAM;
- (ii) 60% of the value on receipt by FlexCAM of material. Payable within 30 days of the invoice date or prior to despatch, whichever is the sooner; and
- (iii) 10% of the value on acceptance or takeover by the Customer or 30 days from delivery, whichever is the sooner. Payable within 30 days of the invoice date..
- 4.2 FlexCAM reserves the right to require payment in full on delivery of the goods or completion of the services.
- 4.3 Payment by cheque is not deemed made until the proceeds of the cheque have cleared.
- 4.4 Payment terms may be revoked or amended at FlexCAM's sole discretion immediately upon giving the Customer written notice.

## 5. Payment Default

5.1 If the Customer defaults in payment by the due date of any amount payable to FlexCAM, then all money which would become payable by the Customer to FlexCAM at a later date on any

- account, becomes immediately due and payable without the requirement of any notice to the Customer, and FlexCAM may, without prejudice to any of its other accrued or contingent rights: charge the Customer interest on any sum due at the prevailing rate pursuant to the Penalty
- Interest Rates Act 1983 (Vic) plus 2 per cent for the period from the due date until the date of payment in full; charge the Customer for, and the Customer must indemnify FlexCAM from, all costs and
- (b) charge the Customer for, and the Customer must indemnify FlexCAM from, all costs and expenses (including without limitation all legal costs, collection agency costs and expenses) incurred by it resulting from the default or in taking action to enforce compliance with the Agreement or to recover any goods;
- (c) cease or suspend supply of any further goods or services to the Customer; and
- (d) by written notice to the Customer, terminate any uncompleted contract with the Customer.
- 5.2 Clauses 5.1(c) and (d) may also be relied upon, at FlexCAM's option:
- (a) where the Customer is a natural person and becomes bankrupt or enters into any scheme of arrangement or any assignment or composition with or for the benefit of his or her creditors or any class of his or her creditors generally; or
- (b) where the Customer is a corporation and, it enters into any scheme of arrangement or any assignment or composition with or for the benefit of its creditors or any class of its creditors generally, or has a liquidator, administrator, receiver or manager or similar functionary appointed in respect of its assets, or any action is taken for, or with the view to, the liquidation (including provisional liquidation), winding up or dissolution without winding up of the Customer.

### 6. Passing of Property

- Until FlexCAM receives full payment in cleared funds for all goods and services supplied by it to the Customer, as well as all other amounts owing to FlexCAM by the Customer:
- (a) title and property in all goods remain vested in FlexCAM and do not pass to the Customer;
- (b) the Customer must hold the goods as Fiduciary Bailee and agent for FlexCAM;
- (c) the Customer must keep the goods separate from its goods and maintain FlexCAM's labelling;
- (d) the Customer must hold the proceeds of sale of the goods on trust for FlexCAM in a separate account with a bank to whom the Customer has not given security, however failure to do so will not affect the Customer's obligation as trustee;
- (e) in addition to its rights under the PPSA, FlexCAM may without notice, enter any premises where it suspects the goods are and remove them, notwithstanding that they may have been attached to other goods not the property of FlexCAM, and for this purpose the Customer irrevocably licences FlexCAM to enter such premises and also indemnifies FlexCAM from and against all costs, claims, demands or actions by any party arising from such action.

### 7. Personal Property Securities Act

- Notwithstanding anything to the contrary contained in these Terms, the PPSA applies to these Terms.
- 7.2 For the purposes of the PPSA:
- (a) terms used in clause 7 that are defined in the PPSA have the same meaning as in the PPSA;
- these Terms are a security agreement and FlexCAM has a Purchase Money Security Interest in all present and future goods supplied by FlexCAM to the Customer and the proceeds of the goods;
- (c) The security interest is a continuing interest irrespective of whether there are monies or obligations owing by the Customer at any particular time; and
- (d) The Customer must do whatever is necessary in order to give a valid security interest over the goods which is able to be registered by FlexCAM on the Personal Property Securities Register.
- 7.3 The security interest arising under this clause 7 attaches to the goods when the goods are collected or dispatched from FlexCAM's premises and not at any later time.
- 7.4 Where permitted by the PPSA, the Customer waives any rights to receive the notifications, verifications, disclosures or other documentation specified under sections 95, 118, 121(4), 130, 132(3)(d), 132(4), 135 and 157 of the PPSA.
- 7.5 To the extent permitted by the PPSA, the Customer agrees that:
- (a) the provisions of Chapter 4 of the PPSA which are for the benefit of the Customer or which place obligations on FlexCAM will apply only to the extent that they are mandatory or FlexCAM agrees to their application in writing; and
- (b) Where FlexCAM has rights in addition to those in Chapter 4 of the PPSA, those rights will continue to apply.
- 7.6 The Customer must immediately upon FlexCAM's request:
- (a) do all things and execute all documents necessary to give effect to the security interest created under this Agreement; and
- (b) Procure from any person considered by FlexCAM to be relevant to its security position such agreements and waivers (including as equivalent to those above) as FlexCAM may at any time require.
- 7.7 FlexCAM may allocate amounts received from the Customer in any manner FlexCAM determines, including in any manner required to preserve any Purchase Money Security Interest it has in the goods supplied.

- 8.1 The risk in the goods and all insurance responsibility for theft, damage or otherwise will pass to the Customer according to applicable INCOTERM rule. The Customer shall bear the risk for goods in transit according to applicable INCOTERM rule, also in case of a system delivery.
- 8.2 The goods are sold to the Customer on the basis that the Customer has obtained all necessary licenses or permits under all relevant laws and regulations in relation to the goods.
  - The Customer assumes all risk and liability for loss, damage or injury to persons or to property of the Customer, or third parties arising out of the use or possession of any of the goods sold by FlexCAM, unless recoverable from FlexCAM on the failure of any statutory guarantee under the

- 15.7 Nothing in the Terms is to be interpreted as excluding, restricting or modifying or having the effect of excluding, restricting or modifying the application of any State or Federal legislation applicable to the sale of goods or supply of services which cannot be excluded, restricted or modified

#### 16. Cancellation

- If FlexCAM is unable to deliver or provide the goods or services, then it may cancel the 16.1 Customer's order (even if it has been accepted) by written notice to the Customer.
- 16.2 No purported cancellation or suspension of an order or any part thereof by the Customer is binding on FlexCAM once the order has been accepted.
- FlexCAM, in its absolute discretion may review, alter or terminate the Customer's credit limit or 16.3 payment terms without notice.
- 16.4 If the Customer cancels the order after acceptance by FlexCAM, then FlexCAM will charge for materials obtained and or work done costs incurred and loss of profit or be entitled to damages

#### 17. Specifications

- 17.1 All specifications, drawings, illustrations descriptive matter and particulars contained in FlexCAM's catalogues, website and marketing documents are indicative only.
- 17.2 FlexCAM reserves the right to make minor modifications to its goods without notice to the Customer and deliver such modified goods against any existing order, unless such right is waived by FlexCAM in writing to the Customer.
- 17.3 The Customer must not reverse engineer any goods provided to it by FlexCAM.
- All drawings, descriptive matter and particulars supplied, remain FlexCAM's property and are to 17.4 be returned to FlexCAM on demand. The Customer must not publish or communicate any of them to any person or publish or permit them to be copied or communicate them to any other person without FlexCAM's prior consent in writing.

#### 18. Intellectual Property

- 18.1 The Customer acknowledges that it has no proprietary right or interest in the Intellectual Property.
- 18.2 The Customer must not register or record or attempt to register or record anywhere in the world the Intellectual Property or any part or any patents, inventions, trademarks or designs derived from or similar to the Intellectual Property or aid or abet anyone else in doing so.
- 183 The Customer must not at any time create, sell, manufacture or process any goods or services using or taking advantage of the Intellectual Property.
- 18.4 Any Intellectual Property provided to the Customer by FlexCAM in connection with the goods and services remains the exclusive property of FlexCAM and must be returned to FlexCAM on demand and must not be copied or communicated to any third party without the express written consent of FlexCAM.
- 18.5 The Customer indemnifies and agrees to keep FlexCAM indemnified against all liability, losses or expenses incurred by FlexCAM in relation to, or in any way directly or indirectly connected with, any breach of any intellectual property rights in relation to the Customer's directions or any intellectual property provided by the Customer to FlexCAM in regard to the supply of the goods or services

#### 19. Warranty

- 191 Where you are a consumer:
  - "Our goods come with guarantees that cannot be excluded under the ACL. You are entitled to a replacement or refund for a major failure and for compensation for any other reasonably foreseeable loss or damage. You are also entitled to have the goods repaired or replaced if the goods fail to be of acceptable quality and the failure does not amount to a major failure."
- 192 The benefits of this warranty in clause 19 are in addition to any rights and remedies imposed by Australian State and Federal legislation that cannot be excluded. Nothing in this warranty is to be interpreted as excluding, restricting or modifying any State or Federal legislation applicable to the supply of goods and services which cannot be excluded, restricted or modified
- 19.3 Subject to the remainder of this clause 19,
- (a) FlexCAM, in its reasonable discretion if it deems necessary, will repair or replace any goods to remedy any failure due to faulty workmanship or materials, provided that the goods may have
- the provision of any replacement parts will be at FlexCAM's cost; (b)
- any replaced or repaired goods will only be warranted for the unexpired portion of the (c) warranty period attached to the original goods;
- FlexCAM reserves the right to replace defective components of the goods with parts and (d) components of similar quality, grade and composition where an identical part or component is
- Goods presented for repair may be replaced by refurbished goods of the same type rather than (e) being repaired and refurbished parts may be used to repair the goods.
- 19.4 The Customer must immediately contact FlexCAM at the contact address listed at clause 19.13 with full details of the alleged defect in the event of any potential warranty matters or claims, with failure to so, possibly voiding the warranty.
- 195 The Customer must make the goods available to FlexCAM, or its representative at its option, for inspection and testing. If such inspection and testing finds no defect in the goods, the Customer must pay FlexCAM's usual costs of service work, evaluation and testing
- 19.6 The Customer must bear the cost of the transport of the goods to and from FlexCAM, or its representative, to make the warranty claim, and all insurance of the goods.
- 197 Provision of the Warranty is subject to
- the Customer not being in breach of this or any Agreement; (a)
- (b) where FlexCAM is not engaged for a Project, no longer than 12 months having elapsed from the date of dispatch of the goods from FlexCAM's warehouse; or the provision of the services, or in the case of the goods being sourced from third party suppliers, no longer than the warranty period provided by the third party, whichever is the shorter;
- where clause (b) above does not apply, no longer than 12 months having elapsed from the (c) date of the completion and acceptance of a Project by the Customer during which time only FlexCAM has attended to warranty issues in accordance with clause (d) below;

- (d) the Customer has not repaired the goods in an unauthorised manner or altered the goods in any way;
- (e) the Customer using and maintaining the goods in accordance with FlexCAM's instructions and in accordance with commonly accepted operating practices;
- (f) correct storage, siting and installation of the goods in accordance with FlexCAM's instructions:
- (g) Any returned parts or goods becoming the property of FlexCAM.
- 19.8 The Warranty excludes:
- damage or alteration to the goods arising from circumstances outside the control of (a) FlexCAM, including, without limitation, power surges, where the goods are not used for their intended purpose, or where goods or any part of them have been changed in any manner;
- (b) the failure of goods that have been manufactured to a Customer's specification or design where the failure was caused by a Customer specification or design fault;
- (c) Any third party equipment that the Customer might have specified.
- 19.9 The Customer warrants to:
- use the goods in accordance with any instructions provided to it by FlexCAM from time to (a)
- (b) apply for all registrations, licences, certifications and planning permits in relation to the goods and the installation of the goods if required by any government or industry authority and that it will apply for such registrations, licences, certifications and planning permits at its cost:
- (c) use the goods in accordance with all government and local regulations, including but not limited to all relevant permits, environmental laws and regulations governing the use, handling and maintenance of the goods;
- (d) Take all necessary and appropriate precautions and safety measures relating to the storage, installation, use, handling and maintenance of the goods.
- In the case of goods not manufactured by FlexCAM but are sourced from third parties, this Warranty will not operate to extend the terms of the original manufacturer of those goods.
- 19.11 FlexCAM makes no express warranties or representations other than set out in this warranty.
- 19.12 The repair or replacement of the goods or part of the goods is the absolute limit of FlexCAM liability under this express warranty.

#### 20. Exhibitions

20.1 The Customer must not display, advertise or exhibit the goods in any exhibition, other than on the Customer's own premises, unless it has obtained FlexCAM's prior written consent.

#### 21. Miscellaneous

- 21.1 The law of Victoria from time to time governs the Terms. The parties agree to the nonexclusive jurisdiction of the courts of Victoria, the Federal Court of Australia, and of courts entitled to hear appeals from those Courts.
- 21.2 FlexCAM's failure to enforce any of these Terms shall not be construed as a waiver of any of FlexCAM's rights.
- If a clause is unenforceable it must be read down to be enforceable or, if it cannot be read down, 21.3 the condition must be severed from the Terms without affecting the enforceability of the remaining conditions.
- 21.4 A notice must be in writing and handed personally or sent by email, facsimile or prepaid mail to the last known address of the addressee. Notices sent by pre-paid post are deemed to be received upon posting. Notices sent by email or facsimile are deemed received on confirmation of successful transmission.

#### 22. Privacv

- FlexCAM is bound by the Privacy Act 1988 and takes steps to ensure that all personal information obtained in connection with the Customer will be appropriately collected, stored, used, disclosed and transferred in accordance with the National Privacy Principles. Such information may be accessed by request to FlexCAM in accordance with the Privacy Act.
- 22.2 The Customer must comply with the National Privacy Principles in connection with any personal information supplied to it in connection with this Agreement
